Kindly clarify on the mandatory requirement to include in the proposal.	The mandatory requirement to include in the proposal are detailed in Clause 22.1 of Information to Consultants (ITC). The Consultant shall use Form TECH-7: MANDATORY DOCUMENTARY EVIDENCE to list and submit all the required support documentary evidence as required in the RFP, especially the mandatory and eligibility criteria specified in Clause ITC 22.1. Under the Data Sheet ITC 22.1, The consultant shall be required to paginate their proposal from Page 1 to the last page.
4.	Your letter, page 10 of 151 in the RFP, guides that the maximum number of JV members shall be specified in DS. However, the data sheet indicates " NOT APPLICABLE " on the maximum number of members in the JV.	The Joint Venture (JV) in this assignment is permissible.
